

Town Inspection Trip May 14, 1979

Left village on Rt. 136, Viewed violation of Dredge & Fill at Milton Elliotts', took Colburn Road at Todds' Corner, Noted more than 1 apparently unregistered vehicle at Rob't Briere. Checked driveway at new house (Gagne) beyond Wm Thompson. Noted that culvert at foot of hill beyond driveway is clogged, also culvert just before Silvernails' also needs cleaning.

Up Rt. 136, right past Geo. Daniels, Gerald Speck & Elliott Hersey. viewed road to LaPenn's.

Checked Kilmartin's logging operation (permit # 12119), operator N. Bergeron, timber sold to R & R Lbr Co. Logs have been dragged across town road with considerable abrasion of gravel surface, also left too close to traveled right-of-way. Informed Steve Perron, Forester, of infraction (he has some connection with Rob't Todd). Mr. Kilmartin rec'd \$ 63 per M on stump. We must have Almus check damage, inform Selectmen of cost of repair, and we will bill responsible parties of costs.

Bridge rails at Prouty's need repair.

Noted possible danger of flooding Town road above Marvell, Jr., checked 1/2 house near Vardaro's (who owns lot), then past Belanger & Burbee, J. Dane (More than Apparently unreg vehicles).

To Ellison & Bouchard (new drilled well) Philibotte & Gaitner.

Who owns old cement garage?? Also new cement garage before Perron house??

Up Rt 77 to Wedick (no response at door) & to Cal Robinson place. REMINDER Consult Cons Comm on possible uses.

Down Twin Bridge road (Middle Branch) observed Town line marker (vicinity of Daniel's Lake). To right on old road to old chimney (Clifton Wilson's camp?) .4 miles from TB road. Timber operation in area ( R. Paradise) ??

Newman Wilson road to N. Wilson place (J. Trimbur) more than 1 unreg vehicle. Noted the many new houses on Trimbur development.

To Goffstown, up Bog road. Marker on culvert at Bog Brook???

To The Kingdom & return past Tracking Station. New (roughed out) driveway near Dunn house. Bucky Leach's ?? gravel pit.

Three (3) potholes near Dancause house.

Luffman (Dancause Private road) Log cabin & trailer (Same lot ??)

House (1st lot East of County Road) needs culvert under drive-way.

Conversation with Mrs. Hapeman (HINMAN place) in re mess on County road, also use of their parking lot across road from her house to unload heavy equipment.
