- A. Call to Order, approve meeting minutes for August 17, 2022 edited minutes approved unanimously
- B. Appointments none
- C. Old Business
 - Department Logo update
 - o The committee (Katie, Helen, Jen) met recently
 - O Staying with the gazebo but updating the font (Jen will send a draft)
 - Brick Order Update
 - Sold so far
 - 42 bricks have been sold so far
 - 39 coozies have been sold so far
 - \$55 cash donation
 - o Will have an ad in Nov and Dec Beacon advertising bricks and cozies
 - Ideas for some brick signage on the common, an article on the gazebo in the Beacon, and/or a mailing to all households in town
 - We do not think that the brick fundraiser will cover the cost of the new roof for the 28-year-old gazebo. It may only cover the cost of the new walkway, need to get information on the cost of the new walkway.
 - Would like the expense to be split by the Recreation Department and the Town
 - May want to do a warrant article in 2024 for the amount (similar to what we did for the bus)
 - Volunteer Brochure and requirements Mike shared ideas for the brochure
 - o Idea is to combine the tri-fold draft with the 'What do I need to be a Recreation Department volunteer?' information
 - Youth Sports Coaches
 - Background check required

 - Recreation Department presenting budget to the Finance Committee on November 10th

 - Donation Account
 - o \$6, 439 balance in the gazebo roof fund
 - o \$2,200 balance for ice rink
 - o \$10,200 balance for baseball/softball
 - o \$1,000 balance in the general facilities
 - Camp Coolio
 - o Revenue is up \$9,200 over last year after expenses
 - O Added more kids and expenses than the past two years
 - Profit and Loss Report
 - o Revenue for the year is \$45,000 over this time last year
 - \$46,000 that was spent on repairs the white buildings (windows and parking lot)
 - Accounts Receivable
 - o \$3,800 owed currently, majority due to upcoming basketball season
 - Accounts 90 days overdue will be suspended until the balance has been made current
 - Two families owe funds:
 - One for Camp Coolio and fall softball fees
 - One for fall softball

 - o Cost \$29,000 for the sign. Electric and pole was donated (~\$10,000)
 - Worked with Sousa Signs
 - Need an update about the status of the emergency grant monies. Mike will check with Dan McDonald
 - o Permitting is not an issue since it is a municipal sign
 - Mike will investigate if there are any other interested departments that would want to contribute. He will also find out more about GHS' new electronic sign.
- Town Hall drainage
 - Drain clogged again in September highway had to come unclog the pipe/drain
 - Need to fix the pipe up the hill that broke hoping it will solve the problem sort-term. Hoping it will be done prior to winter
 - Mike met with Randy Loring from the SAU, because part of it is on school property
- Ice rink liner has been ordered
- Fire panel in white building
 - o Need to determine if it is needed
