- Many positive comments were received about the Powerpoint Budget presentation at the Deliberative Session and the entire Deliberative Session. It is available to review on the town website, official town Facebook page and town hall streams.
- Town Administrator candidates have been interviewed and the Board will consider them further during Non-Public session.
- Jim attended a Lyndeborough Road bridge project summary meeting with the town engineer and FL Merrill to determine the final schedule for bridge completion. A second invoice is anticipated to be submitted within two weeks with work completed in the spring.
- The Select Board requested information in non-public session January 3, 2022 that has not been received yet.
- Karen and Laura received an e-mail of a plowing complaint on Thornton Road. The Highway Department is investigating.

#### **Item 8: Selectmen's Reports:**

David reported the following:

- Planning Board will meet March 14, 2022. A site walk is planned March 12.
- There is information posted on the website about the 2022 Warrant. The Board asked that a summary of the cost of each Article to the taxpayers be added to the website. This information is already available, embedded into each Article.

Karen reported the Road Committee will meet April 13, 2022.

Donna reported the following:

- The Solid Waste Advisory Committee will meet March 7, 2022.
- The group/unofficial broadband committee met January 24, 2022. Donna was unable to attend. Committee member Bill McFadden was present and reported the committee met January 24 with the Energy Commission. The group is at a standstill as they are waiting for needed information from Fidium/Consolidated Communications. Committee member Jennifer Allocca will follow up with them. The Energy Commission met February 15, 2022 to discuss the broadband project. The Commission would like to create a map to display in the lobby on voting day showing where Consolidated Communications and Comcast claim the broadband lines are available. Voters will be surveyed to confirm this at their location on that day.

- Eversource has delayed its rebates, but they are now in place. Interim Town Administrator Jim Brace approved the expedited installation of LED light fixtures around town. This is planned the week of March 7.
- The New Boston Taxpayers' Association is holding its annual meet the candidates night March 6, 2022 at 6:00 PM at the library. Interim Town Administrator Jim Brace approved livestreaming the event. Mark Anderson will moderate the event.
