General Information

1. **Checklist:** The applicant shall complete this checklist as part of every site plan application. The applicant shall either (1) submit the checklist item with the application or request a waiver (s) to be submitted separately in writing or (2) note its non-applicability. This checklist is not intended to be a replacement for thorough review of the Non-Residential Site Plan Review Regulations. This checklist is intended to be used as an aid in the preparation and review of the site plan.
2. **Submissions:** All proposed site plan submissions shall be accompanied by a properly completed, dated and signed Site Plan Review Application.
3. **Filing:** Applications and checklists shall be filed with the Planning Department not less than **21 days** before the regularly scheduled meeting at which it is intended for submission.
4. **Waivers:** For any item checked "Waiver Requested", the applicant must attach a separate letter indicating the reason (s) for seeking a waiver request.
5. **Completeness:** Items required for a completed application are:
 - Completed Application Form
 - Three (3) Copies Floor Plan
 - Four (4) sets site plan maps and supporting data
 - Names and mailing addresses of all abutters
 - Eight legible 11" x 17" copies of site plan
